## MINUTES MOUNTAIN IRON CITY COUNCIL JUNE 15, 2015

Mayor Skalko called the City Council meeting to order at 6:31 p.m. with the following members present: Joe Prebeg, Jr., Susan Tuomela, Tony Zupancich, Alan Stanaway, and Mayor Gary Skalko. Also present were: Craig J. Wainio, City Administrator; Jill M. Clark, Municipal Services Secretary; Michael Downs, Director of Public Works; Rod Flannigan, City Engineer; Sally Yuccas, Librarian Director/Special Events Director; John Backman, Sergeant; Bryan Lindsay, City Attorney; and Greg Chad, Fire Chief.

It was moved by Skalko and seconded by Tuomela that the consent agenda be approved as follows:

- 1. Add the following item to the agenda:
  - VI. B. Resolution Number 13-15, awarding the bid on the storm sewer project
- 2. Approve the amendment to the minutes of the May 18 2015, meeting as follows:

Due to a clerical error made by Saint Louis County, the following motions should be rescinded from the May 18, 2015 City Council meeting:

"It was moved by Prebeg and seconded by Tuomela to accept the recommendation of the Saint Louis County Appraiser and make an adjustment to the improvements to the property of Brandon Tapio, 4929 Voss Road, Mountain Iron, Parcel Code of 175-0071-04036 and reduce the improvement value by \$400, making the improvement total \$226,100. The motion carried."

"It was moved by Prebeg and seconded by Tuomela to accept the recommendation of the Saint Louis County Appraiser and make an adjustment to the improvements to the property of Joanne McGregor, 4860 Butler Road, Mountain Iron, Parcel Code of 175-0071-05023 and reduce the improvement value by \$2,000, making the improvement total \$183,600. The motion carried."

And, replaced with the following:

"It was moved by Prebeg and seconded by Tuomela to accept the recommendation of the Saint Louis County Appraiser and make an adjustment to the improvements to the property of Brandon Tapio, 4929 Voss Road, Mountain Iron, Parcel Code of 175-0071-04036 and reduce the improvement value by \$400, making the improvement total \$197,800. The motion carried."

"It was moved by Prebeg and seconded by Tuomela to accept the recommendation of the Saint Louis County Appraiser and make an adjustment to the improvements to the property of Joanne McGregor, 4860 Butler Road, Mountain Iron, Parcel Code of 175-

0071-05023 and reduce the improvement value by \$2,000, making the improvement total **\$179,600**. The motion carried."

- 3. Approve the minutes of the June 1, 2015, regular meeting as submitted.
- 4. That the communications be accepted and placed on file and those requiring further action by the City Council be acted upon during their proper sequence on the agenda.
- 5. To acknowledge the receipts for the period June 1-15, 2015, totaling \$197,441.00, (a list is attached and made a part of these minutes).
- 6. To authorize the payments of the bills and payroll for the period June 1-15, 2015, totaling \$539,906.01, (a list is attached and made a part of these minutes).

The motion carried on a roll call vote.

During the public forum, Mike Richards, 5426 Bluebell Avenue, was present and requested that the Council direct staff to complete some needed ditching work or fill in the ditches, in the Westgate area. The City Administrator informed him that the property owners would be responsible to hire an engineer and complete the work to City standards or have the neighbors petition the City to have the work completed and then the project would be assessed to the affected property owners. The City Engineer spoke and said that the project was previously considered cost prohibited.

Also during the public forum, Melissa and Paul Smith, 8366 Marigold Street, spoke and asked the City to maintain the ditches.

It was moved by Prebeg and seconded by Zupancich to have the Director of Public Works and the City Engineer review the water situation in the Westgate area, meet with neighbors, investigate the area and come back with a recommendation. The motion carried.

The Mayor reported on the following:

➤ Birthday. Ione Marincel, 102 years old.

It was moved by Stanaway and seconded by Prebeg to authorize the purchase of a Kohler model NEMA Type 3R transfer switch for the generator, to be located at the Community Center, at a cost of \$8,256.00 from Total Energy Systems, LLC. The motion carried unanimously on a roll call vote.

The City Administrator reported on the following:

- Funds to de-commission the Nichols Township ponds. He said that the original approval by the legislature was veto by the governor, but it was approved through the special legislation session.
- > 2014 Audit. The City Auditor will be at the July 6th meeting to review the audit.

It was moved by Prebeg and seconded by Zupancich to direct the City Administrator to send a letter of thanks to Senator Tomassoni for his work in the City receiving the funding to decommission the Nichols Township ponds. The motion carried.

It was moved by Zupancich and seconded by Tuomela to authorize the purchase of a recycling trailer from Wilkens Industries, Inc. at a cost of \$43,326.67 with the City of Eveleth paying for half of the cost of the trailer. The motion carried on a roll call vote.

It was moved by Zupancich and seconded by Tuomela to hire the following as summer temporary employees:

Paul Petersen Jeff Tiedeman

The motion carried.

The Director of Public Works said that the quote submitted for the gravel was not the type quoted, so no further action was taken.

The Director of Public Works reported on the following:

➤ Power Outage. The power was out for approximately two hours on June 14, 2015. The outage was caused by a squirrel on the Virginia Public Utilities line.

The Library Director/Special Events Director reported on the following:

- Wacky Wednesday. There will be a comedy/musical/puppet show on June 17, 2015 at 1:00 p.m. at the Library.
- ➤ Thank you. She thanked Shannon Peterson and Nancy Pickett for all their help at the Library. Also to the City Summer Work Crew, she said that the library grounds look beautiful.
- Fourth of July. Parade is at 9:30 a.m. on July 4<sup>th</sup>. She said that she has a band for the parade. She said she was working on new activities for after the parade at the football field.
- Merritt Day Committee. She distributed the minutes for the last meeting and she said that there is a meeting on Thursday, July 18<sup>th</sup> at 6:00 p.m.

The City Attorney reported that he had been working with law enforcement and the court staff in the area and they are required to transfer to an e-charging system within the next year.

It was moved by Prebeg and seconded by Tuomela to authorize the contract with Architectural Resources to evaluate the possibility of remodeling or adding on to the Fire Hall to create a more desirable space. The motion carried on a roll call vote.

It was moved by Stanaway and seconded by Tuomela to adopt Resolution Number 13-15, accepting the bid on the storm sewer project, (a copy is attached and made a part of these minutes). The motion carried unanimously on a roll call vote.

At 7:15 p.m., it was moved by Zupancich and seconded by Prebeg that the regular meeting be recessed and open the closed session. The motion carried.

At 7:15 p.m., the Mayor called for a five minute recess.

At 7:23 p.m., Mayor Skalko called the closed meeting to order with the following members present: Joe Prebeg, Jr., Susan Tuomela, Tony Zupancich, Alan Stanaway, and Mayor Gary Skalko. Also present were: Craig J. Wainio, City Administrator; and Bryan Lindsay, City Attorney.

At 7:32 p.m., it was moved by Zupancich and seconded by Tuomela to adjourn the closed meeting and reconvene the regular meeting. The motion carried.

It was moved by Zupancich and seconded by Tuomela to approve the Labor Agreement between the City of Mountain Iron and the American Federation of State, County, and Municipal Employees, AFL-CIO, Local Union Number 453, for the period May 1, 2015 through April 30, 2017. The motion carried.

At 7:35 p.m., it was moved by Skalko and seconded by Tuomela that the meeting be adjourned. The motion carried.

## **RESOLUTION NUMBER 12-15**

## DECLARING COST TO BE ASSESSED, AND ORDERING PREPARATION OF PROPOSED ASSESSMENT

WHEREAS, costs have been determined for Improvement Number 13-07, the proposed improvement of Unity Drive between the centerline of Diamond Lane and the centerline of Park Drive by construction and the contract price for such improvement is \$450,311.09, and the expenses incurred in the making of such improvement amount to \$87,079.58 so that the total cost of the improvement will be \$537,390.67.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF MOUNTAIN IRON, MINNESOTA:

- 1. The portion of the cost of such improvement to be paid by the City is hereby declared to be \$53,739.07 and the portion of the cost to be assessed against benefited property owners is declared to be \$483,651.60.
- 2. Assessments shall be payable in equal annual installments extending over a period of 10 years, the first of the installments to be payable on or before the first Monday in January, 2016, and shall bear an interest rate at two percent above the going prime rate per annum from the date of the adoption of the assessment resolution.
- 3. The City Administrator, with the assistance of the city engineer, shall forthwith calculate the proper amount to be specially assessed for such improvement against every assessable lot, piece or parcel of land within the district affected, without regard to cash valuation, as provided by law, and he shall file a copy of such proposed assessment in his office for public inspection.
- 4. The City Administrator shall upon the completion of such proposed assessment, notify the City Council thereof.

#### Councilors:

This week we held to preconstruction meetings, the first was on the Mountain Iron Drive project. It appears that Mesabi Bituminous will begin the Mountain Iron Drive project towards the end of July. The biggest discussion at the meeting was the phasing of the project to keep access to all business through the construction project. Mesabi Bit was instructed to work with all the businesses for the least amount of impact. This week you may have seen some activity at the RR crossing on Unity Drive. This is part of the Mountain Iron Drive project where we are replacing the water main locate under the RR tracks. The City learned that the CN RR was planning on performing some maintenance on the crossing and we took the opportunity to replace the water line while they had the crossing closed. Sounds good in theory, while digging, we were unable to locate the casing in which contains the water line under the tracks, we suspect that when the casing was installed there was only one set of tracks on the north side of Unity Drive. When the second set was added, the end of the casing was covered by the new tracks. As part of the Mountain Iron Drive project, we bid and Add/Alternate for a new casing for this very scenario, on Monday night we are requesting that this Add/Alternate be awarded for the new casing in which we can install the new water main.

The second preconstruction meeting was for the Mud Lake Road force mail project. This project is pretty straight forward and they indicated that work should begin next week with the directional boring.

Lately, we have been working with the IRRRB on a large industrial project looking at the area. The project involves the use of biomass to produce industrial alcohol, it appears that it is between us and Hoyt Lakes, the like our site because of the wood yard. This is not the same project that was previously announced for Hoyt Lakes. Substantial upgrades would be needed to our waste water treatment facilities to accommodate the byproduct of the process, of course the IRRRB would be funding the upgrades needed.

Shortly, I am headed to Duluth to meet with MNDoT and St Louis County concerning the Highway 169 County Road 7 intersection. MNDoT is planning some work in that area and are aware of our concerns so they have included the City in on the discussions. I will keep you posted.

Enclosed please find the Final Environmental Impact Statement (EIS) for the US Highway 53 Virginia to Eveleth project.

As the Responsible Governmental Unit (RGU), the Minnesota Department of Transportation (MnDOT) has prepared a Final EIS in accordance with state requirements for the US Highway 53 Virginia to Eveleth project. The Final EIS describes the transportation and environmental impacts of the preferred alternative: Alternative E-2 (with the Interchange Option and Straight Option).

After the comment period on the state Final EIS, MnDOT will consider any comments received and make an Adequacy Determination.

For the federal environmental process, after the state Adequacy Determination and in accordance with the provisions of the Moving Ahead for Progress in the 21st Century Act (MAP-21), the Federal Highway Administration (FHWA) and MnDOT will be issuing a single document that combines the Final EIS and the Record of Decision (ROD). This publication under federal rules is anticipated to occur in the fall of 2015. The intent to combine these documents was described on the signature page of the Draft EIS. After reviewing the comments received on the Draft EIS, FHWA and MnDOT jointly affirmed the decision to prepare a combined Final EIS/ROD.

Documentation regarding Section 4(f) recreational resource impacts is also included in the Final EIS. FHWA's final *de minimis* determination for the Iron Range Off-Highway Vehicle Recreation Area will be included in the ROD.

Copies of the state Final EIS are being distributed to local governments, regulatory agencies, the Project Advisory Committee, and others in accordance with the EQB requirements.
